A2: Review of Departmental Advisory Committee (DAB) and Board of Studies (BoS) Committee

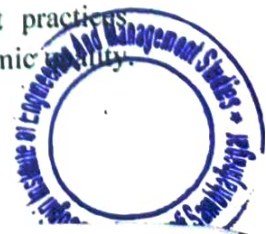

Resolution: It was decided to implement the recommendations of the DAB and BoS Committees for curriculum enrichment, strengthen industry-academia collaboration, introduce value-added and skill-based courses wherever required, and ensure effective implementation of the approved academic and quality improvement initiatives.

A3: Review of Internal Academic Audit – The Internal Academic Audit report was reviewed in detail. The committee discussed the observations and recommendations related to teaching-learning processes, curriculum delivery, course file maintenance, documentation, assessment practices, attainment of Course Outcomes (COs) and Program Outcomes (POs), and overall academic quality.



Faculty members were advised to address the identified gaps and adopt best practices for continuous improvement.
